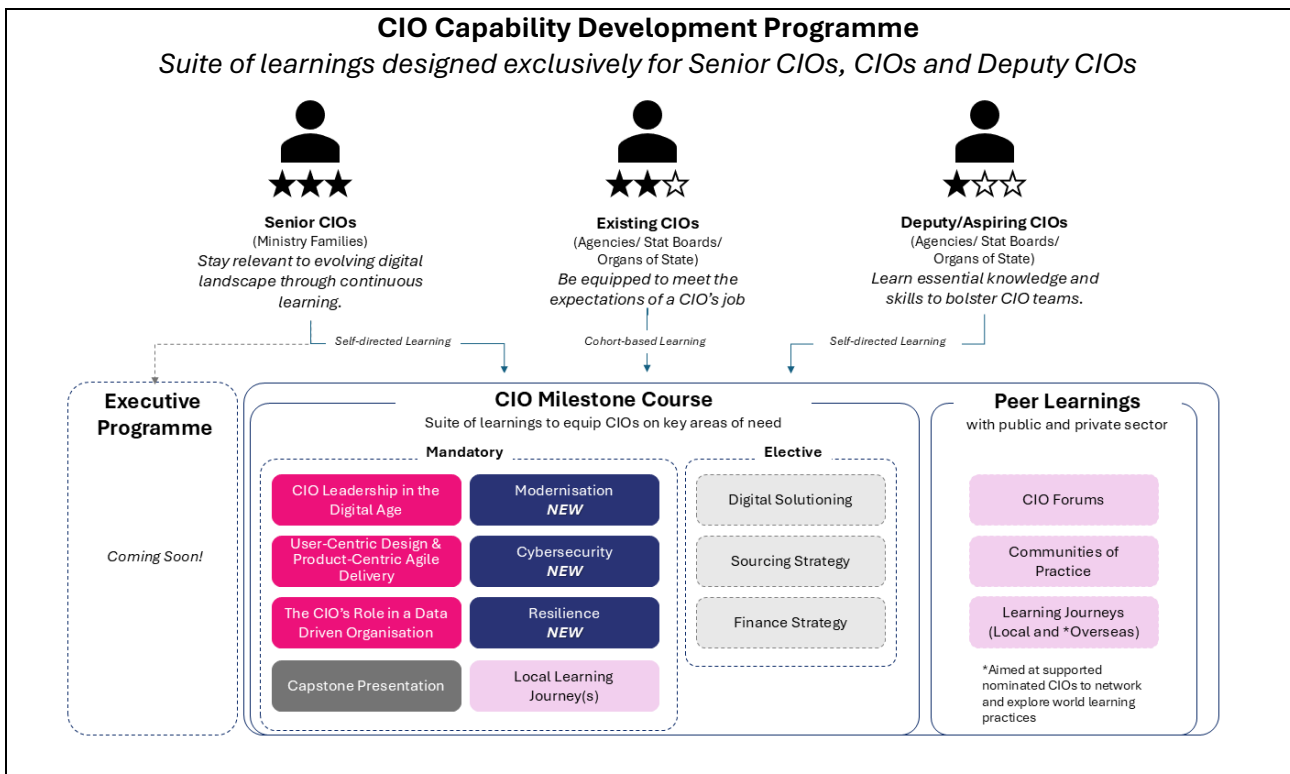


As we work towards building a Digital Government and a Smart Nation, it is essential for CIOs to be well-prepared to align technology initiatives with their agency’s broader digital goals.

Module Title^	Module Synopsis	Mandatory /Elective
CIO Leadership in the Digital Age	This module is a practice-oriented induction into the multifaceted journey of a digital leader, seeding the motivations for deepening perspectives and approaches to be covered in subsequent modules.	Mandatory
User-Centric Design & Product Centric Agile Delivery	This module explores the crucial role of user-centric design and product-centric agile delivery in digital transformation, emphasising the necessary mindset shift for effective implementation.	Mandatory
The CIO’s Role in a Data-driven Organisation + AI	This module explores the CIO's role in leveraging data for digital transformation. It covers partnerships with CDOs, data democratisation benefits, and building robust, scalable data architectures to drive organisational change	Mandatory
Modernisation <i>NEW</i>	This module focuses on IT modernisation, teaching CIOs to define goals with stakeholders, develop strategies, and organise teams. It explores key concepts, challenges, and best practices for updating legacy systems effectively.	Mandatory
Cybersecurity <i>NEW</i>	This module enhances CIOs' cybersecurity knowledge, covering fundamental principles, risk assessment, and incident management. It emphasises the CIO-CISO partnership in strengthening agency cybersecurity posture and preparing for potential incidents.	Mandatory
Resilience <i>NEW</i>	This module explores IT's role in business resilience, focusing on system resilience, disaster recovery, and continuity planning. It covers strategies for existing systems and developing new digital services to enhance organisational resilience against high-impact scenarios.	Mandatory
Digital Solutioning	This module explores the CIO's role in digital solutioning, focusing on emerging technologies like AI, IoT, and blockchain. It enhances CIOs' ability to communicate technology value and opportunities to business leaders effectively.	Elective
Sourcing Strategy	This module explores various sourcing options, helping CIOs select the most appropriate approach for projects. It considers capability, cost, responsiveness, and associated risks, while focusing on essential leadership and management skills.	Elective
Finance Strategy	This module covers financial concepts and digital investment frameworks, enhancing CIOs' ability to optimise investments and influence stakeholders. It uses government case studies to reinforce learning on value, cost, and risk management in digital investments.	Elective

CIO Milestone Course Fees:

The total course fee of CIO Milestone Course is estimated to be between \$17,000 to \$20,000 and this includes six mandatory modules, two learning journeys, and one capstone project. Elective modules are optional and cost an additional \$1,000 per module.
